This Memorandum of Understanding is entered into by the Comunidade de Murda and Sant Sohirobanath Ambiyé, Government College of Arts & Commerce, Virnoda, Pernem Goa-are herein after referred to jointly as the 'Parties'.

The parties having discussed the field of common interests for developing historical knowledge and skill, workshops and seminars on related subjects and allied activities between the two institutions, have decided to enter into a collaboration.

Whereas, SANT SOHIROBANATH AMBIYE, is established under notification No. 10/1/2014 PER (Part) in the Official Gazette, Series I No. 15 dated 10/07/2014 is the State of Goa's Government institute, that provides Higher education and is actively involved in research, co-curricular activities and promotes language and literature.

Whereas, Comunidade de Murda is an autonomous body, governed by the Code of Comunidades legally sanctified by a Legislative Enactment No.2070 dated 15th April 1961, comprising of 325 *Accionistas*, having its office at Merces/Murda Village, discharging socio-economic functions. Being the oldest Goan agrarian-based organization, study of Comunidades is a part of the undergraduate study programme

Whereas, there is a need for both parties to work jointly in order to efficiently achieve their goals through mutual sharing and cooperation and collaborate for mutual benefit.

Now, therefore the parties agree to as follows:

Article - I

- 1.1 The objective of this MoU is to provide a channel of cooperation and facilitate collaboration between the parties to enlighten, and inspire the students to know and understand the different aspects of the governance of the Comunidades in Goa.
- 1.2
 - a) to conduct an academic Programmes for students thereby to develop knowledge and understanding of this heritage institution.
 - b) to sensitize the students about the rural ecology and environment.
 - c) to facilitate study trips to heritage sites, archives and sites of archaeological importance.

Article - II

2. The parties agree to cooperate in the following areas of activity:
 - a) To conduct History subject-related programmes proposed by the Comunidade of Murda, Merces, Goa and SSA Government College, Virnoda, Pernem.
 - b) To provide support in conducting programmes at their premises.
 - c) To collaborate in activities wherever the need arises.
 - d) To acquaint the students with different documentation and records at the Archives of the Comunidade of Murda.
 - e) To conduct visits to the natural heritage sites such as lakes, fountains, salt pans and orchids area

Article – III

Implementation of Memorandum of Understanding

- 3.1 All activities mentioned herein will be conducted as stipulated in the MoU.
- 3.2
- a. SSA Government college will prepare a tentative plan of activities which will be conducted at different levels.
 - b. Comunidade of Murda College will have to identify one faculty as the coordinator for conducting the programmes and activities.
 - c. Both the institutions will contribute finance and other things in equal measure required for conducting the programme.
 - d. The report of the programmes should be mutually prepared by both the parties.

Neither party shall be agent, representative, or joint partner of the other party. Neither party shall enter into any contract or commitment on behalf of the other party.

- 3.4 Neither party shall use the name, logo of the other party or any abbreviation thereof without the prior written approval of the other party.
- 3.5 Nothing in this MoU grants either party the permission to create a hyperlink to the other's website, without the written authorization of the other party.

Article – IV

Term, Termination and Amendment

- 4.1 The proposed MoU is non-exclusive and shall be for three years from the date of commencing on 1-02-2022 till 1-02-2025, unless terminated earlier.
- 4.2 The MoU may be amended mutually by written agreement of the parties.



4.3 SSA Government college will reserve the right for monitoring of the programmes and related activities assigned to the party if financial support is provided by the college as a party.






