
REPORT

A Field Trip for the students and the faculty was organised to the Salt Pans and Orchids to Batim on 14-11-2022 from 9.00 am onwards. In all there were 25 participants including 2 teachers from the Department. The participants were shown the natural salt-making process and also the traditional water management techniques adopted to drain the rainwater from the Salt pans, before the commencement of the season. The students were also shown different methods used to store the Salt during the monsoon. They were also shown the eco friendly tools used during the process.

At the Cashew Orchids/garden students had an opportunity to know and understand the process of extracting the cashew Juice and also the traditional method of distillation. Mr. Anil Sawant, an officer in charge of the Cashew Garden appraised the participants of different varieties of Cashew trees and systems that are in place to ensure its perfect growth. Participants evinced keen interest in knowing the about the traditional methods adopted in producing salt.
