And

Dr. Malik's Farm, Pernem, Goa, represented hereunder by its Mr. Chantanya Bhina Malik, CEO..... (Name and Designation), Indian National, s/o - d/o Mr. Dr. Bhina L. Malik....., married, Indian National, residing at Pernem.....who is duly authorized for this purpose, hereinafter referred to as **the Farm** (which expression shall unless repugnant to the context or meaning mean and include his legal heirs, successors, executors, administrators, legal representatives and permitted assigns) of the **SECOND PART**.

The College and The Farm are herein jointly referred to as “The Parties” and/or individually as “Party No. 1” or the College and “Party no 2” or the Farm respectively.

WHEREAS

1. SANT SOHIROBANATH AMBIYE, is established under notification No. 10/1/2014 PER (Part) in the Official Gazette, Series I No. 15 dated 10/07/2014 is the State of Goa’s Government institute, that provides higher education and actively focuses on over all development of students through effective teaching learning process. The College undertakes various career guidance activities including short term course, hands -on training, experiential learning to equip the students with practical knowledge and develop required skill.

2. Dr. Malik’s farm is an agriculture enterprise of Pernem, Goa practicing agriculture and selling agro products to promote and develop various forms of agriculture as well as create awareness in the state through different activities.

3. The Parties having discussed the field of common interests for agriculture skill development among the students, creating awareness about scopes of agriculture in career and allied activities and knowledge sharing between the two institutions, have decided to enter into a collaboration.

4. The Parties have agree the there is a need for both parties to work jointly in order to efficiently achieve their goals through mutual sharing, exchange, cooperation and collaboration for mutual benefit.

Now, therefore the parties agree to as follows;



Article – I

- 1.1 The purpose of this MoU is to provide a framework of cooperation and facilitate collaboration between the parties to meet the broader goals of developing knowledge and career skills, promoting agriculture as a career option, and providing knowledge relating to agriculture.
- 1.2 The collaboration would enable the College and the Farm to:
 - a) to conduct a number of Programmes, thereby trying to provide knowledge regarding various aspects of agriculture to its students.
 - b) to cater to the needs of the students for skill development by organizing training programmes, presentation, field visit etc. related to agricultural practice.

Article - II

2. The parties agree to cooperate in the following areas of activity:
 - a) to conduct farming related programmes like presentation, talks, training jointly conducted by the Farm and the College.
 - b) to provide support in conducting the programmes at their respective premises as considered necessary.
 - c) to collaborate in activities wherever the need arises.
 - d) to provide student support wherever needed to organize various activities.
 - e) to provide infrastructure to conduct agriculture related activities like seminars, workshops, internships etc.



Article – III
Implementation of Memorandum of Understanding

- 3.1 All activities mentioned herein will be conducted as stipulated in the MoU.
- 3.2 a. The College will prepare a tentative plan of activities which will be conducted at different levels.
- b. The Farm will have to identify one faculty as the coordinator for conducting the programmes and activities.
- c. The College will adhere to the necessary arrangements required for conducting the program.
- d. The report of the program should be mutually prepared by both the parties.
- 3.3 Neither party shall be agent, representative, or joint partner of the other party. Neither party shall enter into any contract or commitment on behalf of the other party.
- 3.4 Neither party shall use the name, logo of the other party or any abbreviation thereof without the prior written approval of the other party.
- 3.5 Nothing in this MoU grants either party the permission to create a hyperlink to the other's website, without the written authorization of the other party.

Article – IV
Term, Termination and Amendment

- 4.1 This MoU is non-exclusive and shall be effective for a period of for two years commencing from ~~1.30~~ May, 2022 up to ~~31.05~~ 2024 unless terminated earlier.


4.2 The MoU may be amended mutually by written agreement of the parties.
