



MEMORANDUM OF UNDERSTANDING

between

and

Dempo Charities Trust's Srinivassa Sinai Dempo College of Commerce
and Economics, Cujira, Bambolim, Goa



This MEMORANDUM OF UNDERSTANDING (here in after, for the sake of brevity, referred to as MoU) is made and entered into on this third of January 2020, between Sant Sohirobanath Ambiyé, Government College of Arts and Commerce, Virnoda, Pernem Goa (here in after, for the sake of brevity, referred to as SSA GCACPG) on the ONE PART and Dempo Charities Trust's Srinivassa Sinai Dempo College of Commerce and Economics, Cujira, Bambolim, Goa (here in after, for the sake of brevity, referred to as SS Dempo), on the OTHER PART.

For the purposes of this MoU, SSA GCACPG and SS Dempo are, here in after, individually referred to as 'PARTY' and collectively referred to as the 'PARTIES'. Further, for the purposes of this MoU, the terms 'SSA GCACPG' and 'SS Dempo' shall, unless repugnant to the meaning or context thereof, shall be deemed to mean and include their successors and assigns;

WHEREAS BOTH SSA GCACPG AND are involved in Education, Research and Training in Commerce, Economics, Computer Studies and Management, Sports;

WHEREAS, SSA GCACPG, is established under notification No. 10/1/2014 PER (Part) in the Official Gazette, Series I No. 15 dated 10/07/2014 is the State of Goa's Government institute, that provides Higher education and is actively involved in research, co-curricular activities and promotes language and literature.

WHEREAS SS Dempo is established in 1966 by the Goa Education Society under the Chairmanship of Shri. Vasantrao S. Dempo, a leading industrialist of Goa, it is one of the oldest and most highly reputed institution for undergraduate Commerce Education (B.Com). It is involved in Research and Training in Commerce, Economics, Management and co-curricular activities;

NOW THEREFORE, in consideration of the premises and mutual covenants here in after contained, the PARTIES here to agree as follows:

Article 1. Objective

To collaborate in the promotion of Sports activities through knowledge sharing, research and organization of events in collaboration to provide competition platform to the students

Article 2. To conduct seminar, workshop, certificate courses for the students and others.

Article 3. General Provisions

3.1 Based on the perceived requirements, the Implementation Committee shall, in consultation with the faculty, members and professionals, decide on the content and implementation of the program of activities during the tenure of this collaboration.

3.2 SSA GCACPG and SS Dempo shall possess the equal responsibility for mobilizing resources and the conduct of such works.

3.3 Each PARTY shall bear their own cost of carrying out the obligations under this MoU. Neither PARTY shall make a claim against the other party for any expenditure unless such expenditure has been agreed upon between the PARTIES.

3.4 Any dispute or difference arising between the PARTIES shall be settled by mutual agreement. The disagreements at the operating level shall be forwarded to the respective higher officials for appropriate resolution.

3.5 Nothing in this MoU is intended to affect any other cooperation or collaboration between the PARTIES.

Article 4. Tenure and Termination

4.1 This MoU shall come into force on the third day of January 2020, upon being executed/signed by the authorized signatories of the PARTIES and shall be valid for three years. It may be amended by mutual written agreement and may be terminated at any time by either PARTY upon one month's written notice to the other PARTY.

Article 5. Amendments

5.1 This MoU represents the entire Understanding between the PARTIES and supersedes any and all understandings either oral or written hitherto with respect to the subject matter of this Understanding.

5.2 No amendment or modification of the MoU shall be valid unless the same is made in writing by both the PARTIES and specifically stating the same to be an amendment of the MoU. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are executed, unless otherwise agreed to.

Article 6. Assignment

6.1 This MoU is based on the professional competence and expertise of each PARTY and, hence, neither PARTY shall transfer or assign this Agreement, or rights or obligations arising thereunder, either wholly or in part, to any third PARTY.

Article 7. Conflict of interest

7.1 Both PARTIES warrant that this MoU is not likely to have any conflict of interest with any of their organizational, financial, contractual or other interests relating to the activities under this MoU.

Article 8. Liability

8.1 Both, SSA GCACPG and SS Dempo shall be solely responsible for any and all claims and/or damages in connection with the exercise of its objectives here under.

8.2 Both PARTIES further agree that no employment relationship or partnership, express or implied, is created between them by virtue of this MoU.

This MoU has been executed in two originals, one of which has been retained by SSA GCACPG and the other by SS Dempo.


